Our representatives obtain information from defendants and provide it to case prosecutors. To be clear, the information often has nothing to do with our clients, but with other active cases. Once the information has been delivered to the prosecutor and confirmed to be accurate and helpful, clients often receive extraordinary allowances concerning their prisons term.

The Process

If you decide to use our services and share vital information with the prosecutor, we will research your claims and court records, then present your confirmed information through the proper legal channels. That means we will hire a lawyer on your behalf to contact the prosecutor after the information has been obtained. In turn, the prosecutor will contact a judge to meet and discuss terms. An agreement will be reached with the police so the information can be legally verified. Once confirmed by the police, the prosecutor will ask for a sentence reduction from the judge. This is the only way to proceed to receive a reduced prison sentence.

We will contact the immigration services and find out which specific agent is assigned to your case, we will work with them to obtain all of the documentation that is required. We will assist in stopping deportation, arranging visas, character references, and such other assistance as may be needed when dealing with the immigration department. Remember that while Huffman's Services are not lawyers or private investigators we are negotiators that sometimes hire lawyers and private investigators to assist us to meet our mission objective.

There is a vast array of options when dealing with the immigration department and it requires knowledge, patience, and an ability to work within that system. Much like obtaining a sentence reduction for a criminal defendant, the Department of Immigration requires various types of confidential information, assistance for their Department to operate, and Huffman's Services is willing to work with them.

Similarly, Huffman's Services will work with parole, probation, and supervised release agents on obtaining various types of Parole and Probation Services. We will carefully review your file, contact the appropriate person, and negotiate with them to accomplish our objective; whether it's a state to state transfer or some specific need, that is important to our clients from supervised release, halfway house, etc.

The key to dealing with parole staff is to understand the rules and what their obligation is. If you're going before parole board we will carefully investigate the members of the parole board, their recent decisions, questions that they normally ask, and what they're looking for and provide you background information so that you are prepared for each individual Parole Board member.

Expenses

Huffman's Services is committed to accomplishing its goals and working within a tight budget with many of our clients. However, in either event, this is an expensive service in which we have to research the records and take the time, trouble, and efforts to negotiate with the authorities. This is a complex time-consuming, sensitive, politically discreet and confidential matter. Additionally, during the course of the sentence reduction process, we may have to retain a lawyer on your behalf, a private investigator or both.

There are two different types of expenses that you will be required to establish. The two retainers are for expenses and our fee. The first retainer is a \$5,000 retainer for expenses and you can expect that the average monthly bill, which we will invoice you for, is \$1,000. As long as you maintain those expenses during the course of the sentence reduction process, we will continue to work on your case until we have accomplished our objective.

Huffman's services must maintain an expense account because when co-operating with the government we may be required to testify by subpoena and the expense of testifying is part of the expense package.

The second retainer we require is a \$5,000 retainer toward our total final fee. Understand that we cannot specifically give you an exact figure of what our total final bill will be because we do not know how much time trouble or effort will be involved to accomplish your specific sentence reduction. However we will work with our clients, their family, friends, and supporters on paying the final total fee as long as the expenses for the costs of the sentence reduction process are maintained during the course of the sentence reduction process.

We require an expenses retainer because we may be subpoenaed by the government many years later to come and testify in some case before court grand juries, law enforcement interviews as a matter related to your sentence reduction.

The average final total bill is \$25,000 but once we are retained we continue to work on the case and we work with our client or client's family, friends, and supporters to pay off the total final bill and it will not stop us from proceeding with the maximum sentence reduction that we can obtain.

Once you decide to retain Huffman's Services we will send you a simple agreement to sign which authorizes us to act on your behalf to retain a lawyer or private investigator or take any such action we deem appropriate necessary to reduce your sentence. You will receive a statement monthly of exactly what our efforts have been and you will have complete contact with Huffman's Services through either our website email or phone.

Many times we are asked why our service is so expensive and we can only respond that there really is no dollar amount one can place on their freedom. Every day is precious while you can earn additional funds you can never get back a day lost of your life.

Negotiations: 1980 - 1989

Even before helping defendants with prison sentences, Huffman worked with a range of other projects. Here are some notable highlights:

- In 1980, he successfully ran a small business charged with negotiating terms with local county authorities.
- While in the US Marine Corps in 1982, he handled federal medical honorable discharges.
- During 1983, Huffman successfully negotiated contracts for a dozen US Army Reserve centers for services with a private company.
- In 1984 and 1985, he worked with county and state prosecutors to reduce a substantial bad check charge to a misdemeanor, changing a 15-year sentence to six months.
- He successfully worked an art fraud charge with a 25-year sentence down to a five-year in 1987.
- In 1989, he brokered the parole of a client in difficult circumstances to an early release to a halfway house.

1990 - 1993

After garnering many successes during the 1980s, Huffman took on more complex cases during the following decade. Though not all are accounted for below, these instances are worthwhile examples:

- In 1990, he worked on a sensitive family court matter that resulted in a minimum amount of child support and visitation rights with a father who had a criminal record.
- With a wire fraud case In 1991, he negotiated terms down to 27 months for a situation involving US Marshalls and extradition. In the end, he arranged for the client to be transferred to a prison of his choice and brokered the earliest possible release date to a halfway house.
- In 1992 and 1993, Huffman took on a business case involving massive debt issues that included federal and state criminal charges, even though federal indictments were dismissed in lieu of state charges. With a 15-year maximum state incarceration term, he secured a two-four year judgment with the earliest release possible.

Other Notable Cases

In addition to successfully negotiating charges for burglary, drugs, and extortion, Richard Huffman has had favorable outcomes in financial cases, too. Huffman convinced federal authorities to give a minor wire fraud charge to an individual, and at the same time persuaded six county and state jurisdictions to dismiss their charges in lieu of the federal charge to run concurrently. He also negotiated testimony for six murder cases before grand juries and all resulted in convictions for the individuals in question.
